COMBINED GRADUATE LEVEL (MAIN) EXAMINATION-2006 – SCHEME-'A'
DECLARATION OF FINAL RESULT

The Staff Selection Commission conducted Combined Graduate Level (Main) Examination-2006 during 4th, 5th, 11th and 12th August, 2007 for the post of Assistant, Sub- Inspectors in CBI, Inspector of Income Tax, Inspector (Central Excise), Inspector (Preventive Officer), Inspector (Examiner) and Inspectors of Posts under Scheme-'A', on the basis of the Combined Graduate Level (Preliminary) Examination, 2006. Interviews/Personality Tests were held subsequently for those eligible candidates who had qualified in the written part of the main examination for posts covered under Scheme 'A'.

2. Following are the lists of **3411** candidates under Scheme 'A' in roll number order, recommended for appointment against the posts of Assistants, SI in CBI, Asstt. Enforcement Officer, Inspector (IT), Inspector (Central Excise), Inspector (Preventive Officer), & Inspector (Examiner) and Inspector of Posts, as indicated below:

The above said Lists are purely **provisional** and subject to the candidates recommended fulfilling all the eligibility conditions prescribed for the respective posts in the Notice of Examination and also subject to thorough verification of their identity with reference to their photograph, signatures, handwritings, etc., on the application forms, admission certificates etc.

10. For candidates belonging to reserved categories for which certain vacancies are reserved as per the policy of the Government, the category status is indicated against their roll numbers. It is important to note that some of these candidates have been declared qualified for the category mentioned against their roll numbers. If any candidate does not actually belong to the category mentioned against his/her roll number, he/she may not be eligible to be included in the list. It is, therefore, in the interest of the candidates concerned to immediately contact the respective Regional Office of the Commission in all such cases where they do not belong to the category shown against their roll numbers.
