COMBINED MATRIC LEVEL (MAIN) EXAMINATION, 2006
DECLARATION OF FINAL RESULT.

The Staff Selection Commission conducted the **Combined Matric Level (Main) Examination, 2006 on 12th & 13th May, 2007** for the posts of **Clerks / Stenographer Grade "D" / Stenographer Grade "C" / Stenographer Grade "III" in CBDT**. In all total of 11,460 candidates were called for typewriting test. Out of this only 7162 candidates appeared in the typewriting test. Out of 31513 candidates qualified in the preliminary Examination for the Matric Level Main Examination, only 3460 candidates appeared for the post of Stenographer Grade-"D" / Stenographer Grade "C" and Stenographer Grade-III in CBDT.

2. Following are the lists of roll number order together with name, respective rank numbers, category, and place of posting of (**LDC : Group-"X": 435 & Group-"Y": 910**), (**Steno Grade "D": Group-"X": 376 & Group-"Y": 351**), (**Steno Grade "C": Group "X": 55**) and **Steno Grade-III in CBDT: 118**) who are recommended by the Commission for appointment against vacancies reported by the user departments / offices in Group "X" and Group "Y" of services / offices subject to their fulfilling all the conditions of eligibility and also the correctness of the information furnished by them in their application forms. In respect of candidates selected under Group-"Y", the roll numbers and names of the candidates have been indicated in the lists for respective States / UTs. The office to which Group "Y" candidates will be initially posted shall be indicated by the Regional Directors concerned. The actual nomination of the candidates and their appointment would depend on the actual vacancies available in the respective department / office, apart from the successful candidates satisfying various conditions of eligibility prescribed in the Notice of the Examination.

3. The result of Shri Vijay Kumar (Roll Number 2850392 for the post of Clerk) and Ms. Babita Das (Roll No. 1265042 for the post of Steno Grade-"D") have been withheld and the same shall be declared subject to final decision of the Hon'ble CAT, Allahabad Bench, Allahabad, and Hon'ble High Court, Delhi, respectively.

4. The results of three candidates namely Shri Srinivasu Duggirala, (Roll No. 6030274), Shri Ranjeet Kumar (Roll No. 4750749) and Shri Vineet Midha, (Roll No. 1222513) have been kept provisional and the same will be verified and cleared by the concerned regional office.

5. For the candidates belonging to reserve categories for whom certain number of vacancies are reserved as per the policy of the Govt., category status has been indicated against their roll numbers. It is important to note that some of these candidates have been declared qualified only for the category mentioned against their roll numbers. If any candidate does not actually belong to the category mentioned against his/ her name, he / she may not be eligible to be included in the list. It is, therefore, in the interest of the candidates concerned to immediately contact the respective Regional Office of the Commission in all such cases where they do not belong to the category shown against their roll numbers.

6. The above said lists are **purely provisional** and subject to the candidates recommended fulfilling all the eligibility conditions prescribed in the Notice of Examination and also subject to thorough verification of their identity with reference to their photograph, signatures, handwritings etc. on the Application Forms, Admission Certificates etc..
