COMBINED GRADUATE LEVEL (MAIN) EXAMINATION, 2008-(SCHEME-A)
DECLARATION OF SUPPLEMENTARY RESULT OF WRITTEN PART

The Staff Selection Commission conducted the Combined Graduate Level(Main) Examination,2008-Scheme 'A' on 22nd , 28th February and 1st March 2009. Due to some administrative reasons, re-examination was conducted on **20.12.2009**, in respect of 9 candidates.

2. The marks of the non-qualified candidates of the said examination was uploaded on SSC's Website on 21.12.2009. Some of the non-qualified candidates represented that their marks were above than the cut-off marks for the candidates called for Interview but were declared non-qualified on the ground that their answer booklets of some of the papers do not contain their signature. As per the provisions of the Notice of the said examination, the candidates who had not appended their signature on the Answer Booklet, the answer booklet had not been evaluated and they were awarded ZERO marks. The result of 33 such candidates has been reviewed.

3. Out of the said 42 candidates (9 candidates of re-examination + 33 without signature cases), following are the lists, in roll number order, of **10** candidates who have qualified in the written examination for the post of Assistant and **20** candidates for the posts of Sub-Inspector in CBI, etc.:

4. The lists herein are **PROVISIONAL**. The candidates whose Roll Numbers figure in the lists would be called for Interview subject to their fulfilling all the eligibility conditions/requirements as prescribed for the respective posts in the 'Notice' of Examination and also subject to thorough verification of their identity with reference to their photographs, signatures, handwritings, etc., on the application forms, admission certificates, etc. If on verification from the application form, it is found that any candidate does not fulfil any of the eligibility conditions, he/she will not be called for the Interview.
5. The Interviews of the qualified eligible candidates will be held on **shortly**. Qualified eligible candidates who do not receive call letters for Interview by **31st March, 2010** should contact concerned Regional Office of the Commission immediately thereafter.
6. For candidates belonging to reserved categories for whom certain percentage of vacancies are reserved as per Government Policy, the category status is indicated against their Roll Numbers. It is important to note that some of these candidates have been declared qualified only for the category mentioned against their Roll Numbers. If any candidate does not actually belong to the category mentioned against his/her name, he/she may not be eligible to be included in the list. It is, therefore, in the interest of the candidates concerned to immediately contact the respective Regional Office of the Commission in all such cases where they do not belong to the category shown against their Roll Numbers.
