

**STAFF SELECTION COMMISSION
FINAL RESULT OF STATISTICAL INVESTIGATORS
GRADE III & COMPILER EXAMINATION 2008.**

The Staff Selection Commission conducted an open competitive examination for recruitment of Statistical Investigators Grade III & Compiler in 33 Directorates of Census Operations, Office of Registrar General of India, located in various States' Capitals & Union Territories.

2. Following is the list of 217 (Statistical Investigator) and 763 (Compiler) candidates in roll number order together with respective rank numbers who have been recommended for appointment subject to verification of their eligibility conditions in all respects against the vacancies finally reported by the user department.

3. The category-wise break-up are as under :-

4. Candidature of 4 candidates (Statistical Investigator Gr.III) and 19 candidates (Compiler) have been kept as provisional. Their rank number will be intimated as and when their candidature will be cleared by the respective RDs.

5. Candidates may note that as per notice of the examination and instructions given in the answer sheets, they were required to code/write their particulars correctly and sign answer sheets. Such answer sheets which are without signature and where particulars such as name, roll no., ticket no. and Test Form no. have been written and/or coded incorrectly, have been rejected/awarded ZERO marks.

6. The lists of recommended candidates are purely PROVISIONAL and subject to the candidates fulfilling all the eligibility conditions prescribed in the Notice of said examination and also subject to, among other things, thorough verification of their identity with reference to their photographs, signatures, handwritings, etc. on the application forms, admission certificates etc.

7. For candidates belonging to reserved categories for whom certain percentage of vacancies are reserved as per policy of the Government, the category status is indicated against their roll numbers. It is important to note that some of these candidates have been declared qualified for the category mentioned against their roll numbers. If any candidate does not actually belong to the category mentioned against his/her name, he/she may not be eligible to be included in the list. It is, therefore, in the interest of candidates concerned to contact immediately the respective Regional Offices of the Commission in all such cases where they do not belong to the categories shown against their Roll Numbers.
