TAX ASSISTANT (INCOME-TAX AND CENTRAL EXCISE) EXAMINATION, 2007
DECLARATION OF FINAL RESULT

The Staff Selection Commission conducted the Tax Assistant (Income-Tax and Central Excise) Examination, 2007 on 25.11.2007 on all-India basis. In all, 6965 candidates qualified in the written part of the examination for appearing in the Skill Test in Data Entry Speed in Computer. The Skill Test was held on 09 th & 10 th August, 2008 .

2. Following are the lists of roll numbers (together with respective rank numbers, category and names) of **1426 candidates including eight provisional candidates** , who are recommended by the Commission for appointment against vacancies reported by the user departments/offices subject to their fulfilling all the conditions of eligibility and also the correctness of the information furnished by them in their application forms.

A list containing roll numbers of eight **provisional** candidates (**CBDT-04 & CBEC-04**) is also given below whose nomination will be subject to their clearance by the respective regional office of SSC in regard to their eligibility in every respect as per Notice of the said examination. The actual nomination of the candidates and their appointment would depend on the actual vacancies available in the user department / office, apart from the successful candidates satisfying various conditions of eligibility prescribed in the Notice of Examination. The '*' appearing alongwith the rank of the candidates in the lists indicates that they have qualified at general standard.

4. For the candidates belonging to reserve categories for whom certain number of vacancies are reserved as per the policy of the Government, category status has been indicated against their roll numbers. It is important to note that some of these candidates have been declared qualified only for the category mentioned against their roll numbers. If any candidate does not actually belong to the category mentioned against his/her name, he/she may not be eligible to be included in the list. It is, therefore, in the interest of the candidates concerned to immediately contact the respective Regional Office of the Commission in all such cases where they do not belong to the category shown against their roll numbers.

5. The above said lists are purely **PROVISIONAL** and subject to the candidates recommended fulfilling all the eligibility conditions prescribed in the Notice of Examination and also subject to thorough verification of their identity with reference to their photographs, signatures, handwritings etc. on the Application Forms, Attendance sheet, OMR Answer Sheets and Answer Book of Paper-II etc.

6. Any query / clarification in respect of this result may be sought by the candidates within six months from the date of publication of result in Employment News / Rozgar Samachar. Thereafter, no correspondence in regard to this result will be entertained by the Commission.
