## Constable (Executive) Male and Female in Delhi Police Examination, 2020- Declaration of Final result-reg.

The Staff Selection Commission declared the result of the Computer Based Examination on 15.03 .2021 wherein 67740 candidates were shortlisted to appear in Physical Endurance and Measurement Test (PE\&MT)/Document Verification. PE\&MT and Document Verification were conducted by Delhi Police.
2. Pursuant to provision under Para No. 15.14 of the Notice of the Examination, a 'Reserve Panel' of $10 \%$ candidates has also been prepared. The 'Reserve Panel' will be maintained and operated by Delhi Police.
