Selection Posts/Ladakh/2023 (Graduation & above Level posts) – Declaration of Result of Computer Based Examination thereby shortlisting candidates **for next stage of scrutiny**

Staff Selection Commission conducted Computer Based Examination for **Graduation & above** Level posts under Selection Posts/Ladakh/2023 Examination from 27-06-2023 to 30-06-2023 at various centers all over the country.

2. Marks scored by the candidates have been normalized as per provisions mentioned under Para 15.3 of the Notice of the examination. Such normalized marks have been used for fixing cut-off marks to qualify candidates for the next stage of Scrutiny.

3. Representations received from candidates regarding tentative Answer Keys were carefully examined and answer keys were suitably modified wherever required and finalized thereafter. The final answer keys have been used for evaluation of performance of candidates in the Examination.

4. As per Para 19.7 of the Notice of the Examination, candidates scoring minimum qualifying marks in the computer based examination, as given below, have been considered eligible for shortlisting to the next stage of Scrutiny:

(i) UR	:	30% (i.e. 60 marks)
(ii) EWS	:	25% (i.e. 50 marks)
(iii) All other reserved categories	:	20% (i.e. 40 marks)

5. As per recruitment procedure mentioned at Para-19.8 of the Notice of the above mentioned Examination, 1093 candidates have been shortlisted for the next stage of scrutiny based on the normalized score and merit of candidates in the Computer Based Examination, in the following ratio:

- (a) 1:30 for vacancies up to 5 (subject to the availability of suitable candidates).
- (b) 1:15 subject to minimum 150 for vacancies more than 5 (subject to the availability of suitable candidates).
- (c) For vacancies reserved for PwBDs/PwBDs-Others/ESMs candidates, all the PwBDs/PwBDs-Others/ESMs candidates who are qualifying with minimum-cutoff criteria are to be shortlisted for scrutiny process.

6. Category-wise break-up of the candidates shortlisted in the Computer Based Examination for the next stage of Scrutiny are as follows:

7. Post-Category wise cut-off details of candidates qualified against vacancies for **Graduation & above** level posts and number of candidates shortlisted, are given in **Annexure-I**.

8. The candidates **who are shortlisted for next stage of scrutiny as per Annexure-I are required to submit a copy of all the supporting Documents** (Self Attested) in respect of Educational Qualification (EQ), Experience, Category, Age, Age-relaxation, etc. (as applicable) **in hard copy along with the print out of their online application form** to the Staff Selection Commission Northern Western Region, by **07th October, 2023 by SPEED POST ONLY**. The candidates should clearly mention the **"Graduation & above level" and "Post-Category No....." on the TOP of the Envelope** while sending the documents to the SSC(NWR) by Speed Post.

9. It may be noted that if a candidate has applied for 3 (three) categories of posts, for example, NW21523, NW21623 and NW21823, then he/ she has to submit his/ her requisite documents in hard copy, to SSC(NWR) for each category of Post i.e. for Post-Category No. NW21523, for Post-Category No. NW21623 and for Post-Category No. NW21823 separately.

NOTE:- IF PRINTOUT OF THE ONLINE APPLICATION FORM ALONGWITH THE REQUISITE DOCUMENTS IN HARD COPY IS NOT RECEIVED IN THE RESPECTIVE REGIONAL OFFICE BY 07th October, 2023, CANDIDATURE OF SUCH CANDIDATES WILL NOT BE CONSIDERED FOR THE SCRUTINY AND FURTHER STAGES OF THE EXAMINATION. THE COMMISSION SHALL NOT BE RESPONSIBLE FOR ANY POSTAL DELAYS.

11. Resolution of tie cases - In the event of tie in scores of candidates in the Computer Based Examination, such cases have been resolved by applying following criteria, one after another, till the tie is resolved, in accordance with Sr. No. 20 of the Notice of examination:

- i. Total marks in Computer Based Examination.
- ii. Marks in Part-A of Computer Based Examination.
- iii. Marks in Part-B of Computer Based Examination.
- iv. Date of Birth, with older candidates placed higher.
- v. Alphabetical order of names (starting with first name)

12. Skill Test, wherever prescribed for any category of post(s) will be conducted from amongst the shortlisted candidates whose hard copies of documents are received and found in order at Scrutiny stage, by the concerned Regional Office of the Commission. Due intimation in advance will be given by the concerned Regional Office i.e. SSC(NWR) to the candidates through their website.

13. All qualified candidates found clear at the Scrutiny Stage for a particular category of post, will be called for Document Verification (DV) by the concerned Regional Office i.e. SSC(NWR). Accordingly, Admission Certificate for Document Verification will be issued by SSC(NWR).

14. Marks of the candidates will not be disclosed at this stage. The candidature of the shortlisted candidates is provisional.

15. For further stages of recruitment, candidates may visit the websites of the concerned Regional Office i.e. SSC(NWR) regularly.
