Phase-VII/2019 Selection Posts Examination (Graduation & above Level for Post Code No. KK11819 and Higher Secondary Level for Post Code No. NR14019) – Declaration of Additional Result of Computer Based Examinations for next stage of scrutiny

In continuation to the result of Computer Based Examination for Phase-VII/Selection Posts/2019 for Graduation & above level and Higher Secondary Level posts already declared on 18.02.2020, wherein candidates were qualified for various post-categories in the ratio of 1:20 or 1:10 (vacancy : candidates), wherever applicable, (as per the Notice of the examination) in the written examination subject to the merit and availability/suitability of candidates, the Commission is hereby shortlisted some additional candidates in pursuance of Addendum to Notice of Phase-VII/2019/Selection Posts dated 20.01.2020. As per the Corrigendum/Addendum of Notice of Phase-VII/2019/Selection Posts, uploaded on the Commission's website dated 20.01.2020, a Para-15 at sub-point (w) was included as under: -

"In case, during the stage of Scrutiny of documents/final Document Verification, the Commission observes that the vacancy(ies) for a particular category of Post(s) is/are not getting filled up completely, an additional number of candidates who have qualified in the Computer Based Examination, shall be called **only for one more time, at the discretion of the Commission** for filling up the number of vacancies not getting filled up, the ratio of 1:20 for vacancies upto 5 and 1:10 for vacancies more than 5."

2. As per provisions of the Notice of the examination, a minimum cut-off criteria [UR – 35% (i.e. 70 marks), EWS/OBC – 30% (i.e. 60marks), All other categories – 25% (i.e. 50 marks)] has been applied while processing the additional result. Candidates who were earlier declared "Not Qualified" as per result dated 18.02.2020, are considered for qualifying in the Additional Result against the reported post-categories in the ratio of 1:20 or 1:10 (vacancy : candidates), wherever applicable, in the written examination subject to the merit and availability/suitability of candidates. Post-Category wise cut-off fixed by the Commission for the candidates considered eligible in the order of merit, for shortlisting to the next Stage of Scrutiny along with number of candidates are as follows:

The additional candidates **who are shortlisted for next stage of scrutiny are required to submit a copy of all the supporting Documents** (Self Attested) in respect of Educational Qualification (EQ), Experience, Category, Age, Age-relaxation, etc. (as applicable) **in hard copy along with the print out of their online application form** to the respective Regional/ Sub-Regional Office(s) to which the Post-Category belongs, within 3 (three) weeks **i.e. up to 22nd February, 2021 by SPEED POST ONLY**. The candidates should clearly mention the **"Graduation & above Level", "Post-Category No. KK11819" for Graduation above level post and "Higher Secondary Level", Post-Category No. NR14019" for Higher Secondary level post on the TOP of the Envelope** while sending the documents to the respective Regional/ Sub-Regional Office(s) by Speed Post.

The candidates can take out the printout of their application form by logging into the website of the Commission (www.ssc.nic.in) using their Login ID & Password.

4. The other conditions & provisions of the Write-up (Graduation & Above level and Higher Secondary Level) uploaded on 18.02.2020, already uploaded on the website of the Commission, shall remain unchanged.
