Inspector (Central Excise/ Examiner/ Preventive Officer), Inspector and Sub-Inspector in CBN (Ministry of Finance), Sub-Inspector/Junior Intelligence Officer in NCB (MHA), Sub-Inspector in CBI and NIA etc., I have gone through the specific requirement of Physical Standards, Physical Tests and Medical Standards, details of which is given at Annexure-XVII of the Notice of Examination. I fully understand that physical and medical standards will be ascertained by the User Departments / Organizations after the declaration of Final Result. - 3. I have gone through the eligibility criteria in respect of Educational Qualification, Age, caste/ category certificate, PwBDs certificate, etc. as prescribed in the notice of examination for the post(s) opted by me.

I certify that I hold the requisite certificates in support of my claim in this regard and undertake to produce the same as and when required including at the time of Document Verification by the concerned User Department / Organization allocated to me after declaration of final result.
