- 7. Resolution of tie cases: In cases where more than one candidate has secured equal aggregate marks in Paper-I + Paper-II, tie has been resolved by applying the following methods one after another in the given order:
  - i) Total marks in Paper-II.
  - ii) Marks in Part (i) of Paper-I (i.e. General Hindi).
  - iii) Date of birth, with older candidates placed higher.
  - iv) Alphabetical order of the names of the candidates.
- 8. There are some candidates whose candidatures have been kept as provisional by the concerned Regional Offices but are also included in the Select List. Concerned User Departments will check the eligibility of such candidates thoroughly at the time of nomination.
- 9. Any discrepancy with respect to the selection/ non-selection/ allocation of post/ User Department, etc. may be brought to the Notice of the Commission within a period of one month. Any such representation received after one month will not be entertained by the Commission.
- 10. If a candidate is finally selected and does not receive any communication from the Commission or the concerned User Department within a period of one year after declaration of final result, he/she must bring this to the notice of the User Department immediately thereafter.

11. Marks of the qualified and non-qualified candidates will be uploaded on the website of the Commission on 17.11.2020. This facility will be available for a period of one month i.e. from 17.11.2020 to 16.12.2020.
