Candidates may please refer to the Notice of Junior Engineer (Civil, Mechanical, Electrical and Quality Surveying & Contracts) Examination, 2022 published by the Commission on its website on 12.08.2022. In view of the decision of the Government for recruitment to be made in mission mode and to expedite the whole recruitment process, it has been decided that the document verification shall be conducted by indenting Departments/Organizations. A provision to this effect has been included in the Notice of Examination.

- 2. Thus, the Document Verification would be conducted by the indenting Departments/Organizations after the declaration of final result by the Staff Selection Commission.
- 3. Staff Selection Commission had conducted Paper-I (Computer Based Examination) of Junior Engineer (Civil, Mechanical, Electrical and Quality Surveying & Contracts) Examination from 14.11.2022 to 16.11.2022 and the result of paper-I was declared on 18.01.2023. Paper-II is scheduled to be conducted on 26.02.2023. Before declaration of the final result, all the candidates appearing in Paper-II would be required to submit Option-cum-Preference for post(s)/department(s) for which they would like to be considered. For this purpose, a tab/link shall be provided on the login portal of such candidates and the tab/link would be activated for a few days, the information about which would also be notified on the website of SSC (Headquarters) and its Regional/ Sub-Regional Offices. Accordingly, all the candidates appearing in Paper-II are advised to keep a close watch on the website of the Commission for further updates in this regard and to mandatorily exercise their Option-cum-Preference through their respective 'Candidate Login' when the tab/link is activated so that their candidature can be considered for the final merit list / final selection in aforesaid examination.
- 4. The candidates should, therefore, visit the Commission's website as well as the website of their respective Regional/ Sub-Regional Offices from where they have appeared in Examinations regularly for updates on the activation of the tab/link. Candidates, who fail to exercise their Option-cum-Preference during the specified period, shall not be given any further opportunity for submission of their Option-cum-Preference and such candidates will not be considered for inclusion in the final merit list / final selection.
