Sub-Inspector in Delhi Police and CAPFs Examination, 2020 - Result of Paper-I for qualifying candidates to appear in Physical Standard Test (PST)/ Physical Endurance Test (PET) – reg.

The Staff Selection Commission conducted Computer Based Examination for recruitment of Sub-Inspectors in Delhi Police and CAPFs Examination, 2020 (Paper-I) from 23.11.2020 to 25.11.2020.

2. Marks scored by the candidates have been normalized as per the provisions of the Notice of Examination (Para-11.3). Such normalized marks have been used for processing the result. Bonus marks have been provisionally awarded to those candidates who have claimed to hold National Cadet Corps (NCC) Certificate in their Application Form. Such Candidates will have to substantiate their claim at the time of Document Verification (DV).

2.1. As per the provisions of the Notice of Examination (Para – 14.3), minimum qualifying marks in Paper-I have been fixed as follows: UR: 30% (i.e. 60 marks), OBC/ EWS: 25% (i.e. 50 marks) and all other categories: 20% (i.e. 40 marks), without adding bonus marks to NCC Certificate holders.

3. Based on the cut-off fixed by the Commission in Paper-I, number of candidates qualifying for appearing in PET/ PST are as follows:
