Sub: Junior Engineers (Civil, Mechanical, Electrical and Quantity Surveying & Contract) Examination, 2017 – Declaration of Final result - reg.

Junior Engineers (Civil, Mechanical, Electrical and Quantity Surveying & Contract) Examination, 2017 – Paper II was held on 29.04.2018. The result of Paper-II for calling candidates for Document Verification was declared on 22.06.2018.

2. On the basis of Cut-Off marks fixed by the Commission in Paper-II, 1280 candidates qualified in Civil Engineering and 319 candidates qualified in Electrical/ Mechanical Engineering for Document Verification.

3. Consequent upon Document Verification, 341 candidates have finally qualified for appointment. Allocation of Posts and Departments to the qualified candidates has been made on the basis of 'merit-cum-order of preference of Departments' exercised by the candidates at the time of Document Verification. Keeping in view the vacancy position, category-wise details of the 341 candidates (256 Civil Engineering, 40 Electrical Engineering and 45 Mechanical Engineering) qualified for appointment to the posts in different Departments are given below:-
