OFFICE MEMORANDUM

It is requested that the applications of suitable officers who are willing and eligible for the post and who can be spared immediately in the event of selection, may be sent at the following address within a period of <u>sixty days</u> from the date of uploading of this vacancy circular in the website of Staff Selection Commission i.e. www.ssc.nic.in:
