- 3. The Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the Central Government shall ordinarily not exceed three years.
- 4. For the purpose of appointment on deputation basis, the service rendered on a regular basis by an officer prior to the date 1st January, 2006 or the date from which the revised pay structure based on the recommendations of the Sixth Central Pay Commission recommendation has been extended shall be deemed to be service rendered in the corresponding grade pay or pay scale extended based on the recommendation of the said Pay Commission except where there has been merger of more than one pre-revised scale of pay into one grade with a common grade pay or pay scale and where this benefit will be extended only for the post(s) for which the grade pay or pay scale is the normal replacement grade without any up gradation.
- 5. The maximum age limit for appointment on deputation shall be 56 years as on closing date of receipt of applications.
- 6. Pay and allowances of the officer selected will be regulated in accordance with the Department of Personnel & Training's O.M.No.2/29/91Estt(Pay-II), dated 05.01.1994 as amended from time to time.
- 7. Nomination of the officials who volunteer for the post once accepted by this office will not be permitted to be withdrawn.
- 8. Suitable officials submitting his/her application in the given proforma at Annexure-I, who are eligible and who can be spared, may be forwarded to the undersigned alongwith duly filled in Annexure-II in duplicate latest by 23.01.2017, attaching therewith Xerox copies of their CR/APAR dossiers of last 5 years and the vigilance clearance certificate.
