Combined Graduate Level Examination, 2015

The Commission had vide its Notice hosted on the website of the Commission on 20th January, 2016, informed that the results of Tier-II of the Combined Graduate Level (CGL) Examination 2015, were likely to be declared in the third week of February, 2016. The Commission has thereafter worked assiduously to further compress the time schedule and it is now proposed to declare the results of Tier-II of CGL Examination 2015 by the evening of 9th February, 2016.

- 2. In order to ensure greater transparency in the examination system, and in the interest of the candidates, the Commission would upload the final Answer Keys, the OMR sheets and marks of the candidates, on the Website of the Commission on $12^{\rm th}$ February, 2016 at 1200 hours. The candidates can take a print out of their respective OMR sheets along with the final Answer Key, on payment of administrative charges of Rs 20/-. This facility would be available upto $31^{\rm st}$ March, 2016.
- 3. In accordance with the directions of the Hon'ble Prime Minister, the Commission has dispensed with interviews for the All India Open Competitive Examinations conducted by it as also for recruitment to Selection Posts for all categories w.e.f. 1st January, 2016. However, in those limited cases, such as CGL Examination 2015, where the Notice of the Examination was issued before the said decision of the Government and the selection process is in an advanced stage, the process would require to be completed in consonance with the extant scheme of the Examination. Accordingly, interviews would be held for the CGL Examination 2015.
- 4. The candidates are also informed that there are a total 8624 vacancies (3724 for Interview posts and 4900 for Non-Interview posts) to be filled through the said examination, i.e. CGL Examination 2015. The interview /CPT/Skill test for the CGL Examination 2015 are provisionally scheduled to commence w.e.f. 27th February, 2016.
- 5. Accordingly, the Commission tentatively proposes to declare the final results of CGL Examination 2015, by the third week of April, 2016.

- 3. Candidates may note that :-
 - Revised options can be submitted during the document verification, if they desire, which will be final. If options are not revised, the option submitted in the applications will be accepted as final
 - ii) Any candidate qualifying for Interview in List-I and List-II will be required to appear for Interview only once. Similarly, any candidate qualifying in more than one List would be required to appear for Skill Test (DEST/CPT) only once.
 - iii) All the candidates declared qualified in List-III will be called for Document verification/DEST. Candidates qualified in List-III for non-interview posts including the post of Tax Assistants are required to come specifically for document verification, otherwise they will not be considered for final selection.
 - iv) Candidates declared qualified in List-I who have also opted for the post of Assistant in CSS will be called for Computer Proficiency Test (CPT).
 - v) The candidates called for CPT will not be called for DEST separately and Module-I of CPT will be taken for evaluating their performance against DEST.
 - vi) All candidates listed in List-I, List-II or List-III need to appear for document verification once. Candidates who do not attend document verification will not be considered for final selection.
- 4. OMR Answer Sheet of 159 candidates have been referred to CFSL and their result has not been declared. In addition, the result of 52 candidates is being kept in sealed cover as per the CAT/Court order. The result of one candidate is withheld for further examination. Out of these 212 (159+52+1) candidates, 24 candidates are from List-I and 34 candidates from List-III.

- 5. The lists herein **are provisional.** The candidates whose Roll numbers figure in the lists would be called for Interview/Skill Test/document verification subject to their fulfilling all the eligibility conditions/requirements as prescribed for the respective posts in the 'Notice' of Examination and also subject to thorough verification of their identity with reference to their photographs, signatures, handwritings, preference, etc., on the application forms, admission certificates, etc. If, on verification, it is found that any candidate does not fulfill any of the eligibility conditions, he/she will not be allowed to attend the Interview/Skill Test.
- 6. The category of the candidates has been indicated along with their roll numbers. If any candidate finds a mismatch between his/her name, roll number and category, he/she must bring it to the notice of the respective Regional Office of the Commission immediately.
- 7. The Interview/Skill Test for the CGL Examination, 2015 are provisionally scheduled to commence w.e.f. 27th February, 2016. The schedule will be available on concerned Regional Office's website. Qualified eligible candidates, who do not receive call letters for the Interview/Skill Test/document verification, should contact the concerned Regional Offices of the Commission immediately.
- 8. Representations received from the candidates about the answer keys have been carefully examined and the answer keys have been modified wherever necessary. The modified answer keys have been used for evaluation.
- 9. OMR answer sheet of the candidates who did not code their particulars correctly have not been evaluated. OMR answer sheet of the candidates who were in possession of mobile phone and / or electronic devices have not also been evaluated.
