- 2. The bidders are advised not to erase or mutilate figures etc. otherwise their quotations will be ignored. Any overwriting will not be allowed.
- 3. The intending bidders should have experience in the related field for Sales/AMC. The firm should have adequate qualified manpower having experience in the field.
- 4. No advance payment will be made in any case. The payment will be released on successful installation and satisfactory performance of CCTV cameras. The company will submit work completion report after completion of the work.
- 5. Warranty period may clerarly be mentioned in the quoteation. The rates mentioned will be valid for one year from the date of submission of rates.
- 6. Whenever the system cannot be repaired on site within the specified time limits, the company will have the option to take the equipment to their workshop premises with prior permission from the Commission and provide alternative equipment of same or better specifications. The Commission's equipment in any case will have to be repaired/set right within 3 days and returned to the Commission after repair. The firm will arrange their own transport for which extra payment will not be made.
- 7. For preventive maintenance checks of each system which are under Warranty will have to be carried out by the firm on a quarterly basis and will have to be certified by the respective users.
- 8. The personnel of the company will comply with all the security regulations in the Department. Any breach of this condition will render the entire contract null and void.
- 9. Bidder must have to give copy of PAN Card and TIN or Service Tax, number. In the absence of PAN, TIN or ST number, rates quoted will not be considered.
- 10. Rates will not be considered component wise. Lowest rates, as a whole will be considered for award of work order.
- 11. The Commission reserves the right to cancel any or all the quotations without assigning any reason. The bidders will not be entitled to claim any compensation against such cancellation.
- 12. 10% of the total cost offered by the firm has to be submitted as Security Deposit alongwith the quotation in the form of Demand Draft in favour of DDO, Staff Selection Commission, New Delhi. Security Deposit of unsuccessful bidders will be returned. However, security deposit of successful bidder will only be released on the successful installation and satisfactory functioning of the CCTV camera. In case firm fails to execute work within fifteen working days, security deposit will be forfeited.
