Annexure-II

Terms & Conditions

- 1. The representative of the firm will pick up and drop upholstery at the premises of the Commission and no cartage will be paid by the Commission. The Firm will also upload curtains and will hang after washing the same.
- 2. Contract may be terminated by the Commission at any point of time if services provided by the firm are not found satisfactory.
- 3. Firm will be liable to pay the damage/lose, if any made to upholstery by the firm penalty of up to Rs.500/- per item.
- 4. Firm will submit bills immediately after the execution of work and payment will be made.
- 5. In any dispute, decision of the Commission will be final and binding upon the contractor.
- 6. If the services rendered are found satisfactory extension of contract may be considered by the Commission for further one year.
- 7. Rate quoted will be inclusive of all taxes. The Commission will not pay any kind of Taxes on the rates quoted by the firms/ vendors.
- 8. Commission reserves the right to reject any or all the tenders without assigning any reason thereof and is under no obligation to inform the affected bidder or bidders of the grounds for Commission's action.
- 9. Any overwriting in the Tender/ late submission of Tender will not be entertained.
- 10. All documents attached with the bid form should be self attested by the authorized signatory/bidder.
- 11. Rates quoted by the firm will be valid for one year. No escalation in rate will be entertained.
- 12. The bidder who will quote lowest rate in maximum number of items as per Performa at **Annexure-I** will only be considered qualified as L-1 and will be awarded contract subject to fulfillment of all terms and conditions of NIT.
- **13.** Firms have to deposit performance security / performance bank guarantee of Rs.2,000/-(Rupees two thousand only) which will be forfeited in case of violation of terms and conditions of the tender. The performance security will be returned after completion of the contract without any interest.
- 14. The period of contract will initially be for one year from the date of award of the contract. The contract can further be extended for another one year, if the services rendered by the firm will be satisfactory. However, it is at the discretion of the Commission to consider extension on the request of the firm or invite fresh quotations.

15. The Commission (Hqrs) is entitled to terminate the contract without assigning any reason by giving one calendar month notice of its intention to do so.
